# December 16, 2012

### II. Discussion

- Discussion around forming a new HRN Finance Committee and a 2013 schedule.
- Discussion around updating the HRN Articles of Incorporation. Sections around HRN members will be removed. We need the flexibility to change membership requirements in the By-Laws and other HRN documents.
- Discussion around HRNBOD membership and how they are voted into office and term durations.
- HRNBOD voted to accept updated version of the HRN By-Laws.
- Discussion around HRN documents, property with former HRN members and access to the HRN Shelter.

### III. Roundtable

- HRNBOD discussed the details with the Liability Insurance costs to make the best cost effective decision for HRN.
- The Board asked the HRN Shelter managers to obtain general idea of the upcoming 2013 Billerica MA lease renewal.
- HRNBOD asked HRN Shelter general questions about current adoptions, adoption process, newsletters, new memberships, new volunteers, Mid-Shift volunteers and the new volunteer sign up process.
- HRNBOD revised and updated the HRN Articles of Incorporation to submit to the HRN members for a vote in January 2013.

## December 16, 2012

- HRNBOD to ask for volunteers at the January 2013 meeting to form a committee to work on HRNBOD structure and qualifications of new HRNBOD members.
- The HRNBOD accepted all the updated changes (pending any found minor spelling modifications) to the HRN By-Laws.
- HRNBOD contemplating next steps to procure all HRN documents and equipment that may be with former HRNBOD members or HRN members. HRN Shelter Manager offered to contact additionally to see if another result is achieved.
